# **Our Priorities for Continued School Improvement 2016-17**

Towards the end of every summer term Mrs Webster-Smith, the leadership team and governors start identifying the priorities for ongoing school improvement for the coming year. We consider the results from our in house assessment and those of the national SAT Tests. In addition to attainment we look at the progress the children have made since starting at Uplands and over the previous year. We consider any changes in the national curriculum, assessment and new legislation. We also listen to feedback from our teachers, pupils and parents. For example pupil and parent feedback on school dinners last year has played a part in determining a focus on Healthy Lifestyles. Each governor is responsible for monitoring a School Improvement Priority (or an element of it) to ensure that the goals and targets we have agreed for the school are being met.

The four key priorities for school improvement for 2016-17 are:

# 1. The effectiveness of Leadership, Management and Governance

Our focus here is to look at the development of our staff and governors, to help them excel at what they do by ensuring they have the knowledge and skills and opportunities to carry out their roles. In particular we are focussing on our year leaders to enable them to lead and coach their teams and subject areas effectively. We have also revised our reporting and monitoring systems in order that staff and governors can take ownership of school improvement and have the opportunity to lead specific aspects of school.

# 2. The Quality of Teaching, Learning and Assessment

Mrs Webster-Smith and the leadership team continue to look for opportunities to raise the standard of teaching and improve pupils' learning. We identify which elements of a subject need closer attention and what new initiatives are appropriate to our children's needs.

Our aim is to consolidate some of the teaching initiatives that were introduced last year in relation to children's comprehension skills in Reading and also the teaching of Writing and grammar. This year our focus is on developing greater reasoning skills in maths.

We have also agreed to make assessment in school a priority. Without a nationwide assessment system we have to ensure that Uplands' judgements against Age Related Expectations are consistent with those across the country. To do this our teaching staff need a very clear knowledge of the assessment criteria and process.



In this priority we focus on the children's health, welfare, development and how they behave and learn. We want to encourage and enable our children to be independent learners, to be resilient, to have respect and appreciate British Values.

We also want our pupils to know about healthy diets and the basic requirements for looking after themselves, keeping well and safe. This is achieved by not only what is taught in lessons but through the example school sets and the opportunities that it provides. For instance the sports clubs, dance activities, playground activities, the school environment and healthier school dinners and snacks.

# **4. Outcomes for Pupils**

We want <u>all</u> our children to progress in their learning and achieve the best they can. Some groups of children may require additional help to achieve this, their goals might be different but we want to ensure their rate of progress is similar to the rest of the school. Our priority is to ensure their individual needs are being met and that expectations for these and all of our pupils children remains high.

Behind all these priorities are detailed plans that the Senior Leadership Team and governors will continue to monitor through the year.

### **Sickness Absence from School**

Earlier this term the governors approved a revised attendance policy. This includes the procedures for notifying school if your child is off sick.

If your child is off sick from school we ask that you <u>call the school daily</u> to let staff know. If not Uplands School office will text you to check on the whereabouts of your child. We do this to ensure your child is safe. We do not want to assume that your child is still safely at home without your confirmation.

We are grateful for your co-operation.

Our thanks as always to the PTA for their ongoing support, for organising events and purchasing resources for the school. This year with your support the PTA has helped to fund the refurbishment of the school library and a wooden gazebo for outdoor use.
